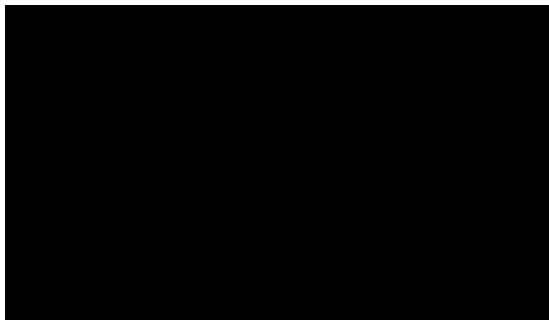
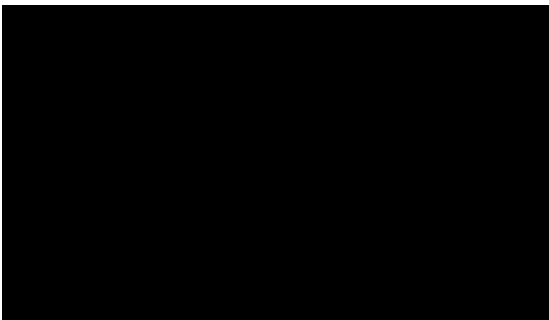
what Bay Shore always does - come together so that we emerge from this situation stronger.

Voter Eligibility and Registration Information

- A citizen of the United States who is eighteen (18) years of age or older.
- A resident in the Bay Shore School District for thirty (30) days or more preceding the day of the vote.
- A qualified voter can register with either the local county board of elections or the school district to be eligible to vote. Because of the pandemic and the closure of school, school districts cannot conduct registration of voters at the school building and there is no statutory authorization for the school voter registration process to be conducted by electronic means. However, prospective voters can still register to vote with the local county board of elections by completing an online application with the New York State Department of Motor Vehicles at <https://dmv.ny.gov/more-info/electronic-voterregistration-application>.

Absentee Ballots

Absentee ballots will be mailed to all eligible voters in the district. Absentee ballots must be received no later than 5:00 p.m. on Tuesday, June 9, 2020. If you require additional information, please contact Nadine Summers, District Clerk, at nsummers@bayshoreschools.org.

Elegibilidad del Votante e Información De Registro

- Un ciudadano de los Estados Unidos que tiene dieciocho (18) años de edad o más.
- Un residente en el Distrito Escolar de Bay Shore durante treinta (30) días o más antes del día de la votación.
- Un votante calificado puede registrarse en la junta electoral local del condado o en el distrito escolar para ser elegible para votar. Debido a la pandemia y al cierre de la escuela, los distritos escolares no pueden realizar el registro de votantes en el edificio escolar y no existe una autorización legal para que el proceso de registro de votantes de la escuela se realice por medios electrónicos. Sin embargo, los posibles votantes aun pueden registrarse para votar en la junta electoral local del condado completando una solicitud en línea con el Departamento de Vehículos Motorizados del Estado de Nueva York en <https://dmv.ny.gov/more-info/electronic-voterregistration-application>.
